



# CONDITIONS OF AGREEMENT

1. By Signing this exhibit space application, and upon acceptance by an officer of Kawartha Lakes This Week, you hereby agree that you will indemnify and hold Kawartha Lakes Week, its management and employees harmless from any claims of any kind, damages, costs, and any liability arising from any injury or damage to any person or thing, including the general public arising out of your occupancy of the exhibit space and including space immediately contiguous to the said exhibit space.
2. Exhibit space contracted for by the exhibitor may not be sublet or shared by other exhibitors without the express written consent from an officer of Kawartha Lakes This Week.
3. This agreement may be terminated by either party provided written notice is received by the other at least thirty (30) days prior to the first day of the show, in which case all deposits paid by the exhibitor shall be refunded, if the exhibitor cancels after this date, the full amount shall become due and payable as liquidated damages.
4. This agreement may be terminated by show management at any time on the breach of any of the conditions hereof by the exhibitor, and thereupon all his/her rights contained herein shall cease and terminate, and any payments made by him/her on account thereof to said termination shall be retained by Kawartha Lakes This Week as liquidated damages for such breach, and show management may thereupon lease said space.
5. Show management agrees to provide standard booth drapery as a backdrop and side rail as required, 2 chairs & table and one (1) dual electrical outlet (15 amps) per exhibit space if requested, in the event larger service is required, the exhibitor agrees to make such arrangements with the authorized show electrician, such charges to be for the account of the exhibitor.
6. All property used or exhibited is at the sole risk of the exhibitor, and Kawartha Lakes This Week, its management and staff will not assume liability for the safety of the exhibits against fire, theft, robbery, accidents or for any cause whatever, or the bodily injury or damage to property caused by the operations of the exhibitor, it is the exhibitors sole responsibility to insure all its good, equipment and staff for all risks including liability for the injury of any person or thing including the general public arising out of the occupancy of the exhibit space.
7. We ask that exhibitors do not bring children under the age of 12 while they are occupying and managing their booth space during the show.
8. In the event this agreement must be cancelled by Kawartha Lakes This Week for reasons beyond its control, the giving of such notice shall operate as a release, one party to the other of the herein agreement. Kawartha Lakes This Week shall refund to the exhibitor all monies paid on account, Kawartha Lakes This Week and its management shall not be liable for any damages of any nature whatsoever, caused by Kawartha Lakes This Week being unable to provide the space contracted for herein, nor for any damages or loss of any nature suffered by the exhibitor in the preparation for the show.
9. The exhibitor agrees that all equipment, materials and devices including without limitations, radio, television, moving pictures, computers, sound and visual aids will be operated in such a manner and location as to cause no inconvenience to the exhibitors or the general public.
10. Should any collection proceedings be deemed necessary by Kawartha Lakes This Week, a \$30,00 administration fee shall apply and be charged. If any cheques issued by the exhibitor are returned by the exhibitors financial institution for any reason than a service change of \$25.00 shall be applied to the exhibitors account. Interest shall be charged for outstanding accounts over thirty (30) days at the rate of 2% per month on the unpaid balance, and shall be applied to the exhibitors account.
11. When accepted by an officer of Kawartha Lakes This Week this agreement shall be binding upon the parties and their respective heirs, executors, administrators, successors and assigns.
12. Exhibitors must park all vehicles in designated vendor parking and NOT in any designated customer parking areas such as the west parking lot.
13. No parking company vehicles/trailers.
